What personal data do we collect?

The camera surveillance register consists of digital image recordings from surveillance cameras. In addition to the image, the register contains information about the area where the camera is located and the date and time of the events in the image. The register may also contain information on vehicles and their holders/owners moving in certain areas covered by the register. In camera surveillance, the view outside the surveillance area is blocked by technical means.

Purpose of processing personal data

Camera surveillance ensures the safety of premises and people. The purpose of camera surveillance is to protect property, the safety of staff and visitors, prevent crime and damage, and assist in the investigation of crime and damage that has already occurred. The authority directive on the protection of critical infrastructure must be followed.

Legal basis for processing personal data

Principles of personal data protection

Access to digital recordings is restricted. Images or image recordings are processed only by persons responsible for the use and/or maintenance of the equipment and by persons whose duties include the processing of recordings, who have received adequate training and who are bound by a legal or contractual obligation of confidentiality.

The servers are secured by technical means and the communication between the systems is encrypted.

Disclosures of data

We disclose personal data in accordance with the requirements of the competent authorities or where it is necessary for the purpose of investigating criminal offences, misconduct, accidents or incidents, in accordance with applicable law.

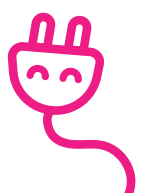
Data retention period

The retention period is a maximum of three (3) months from the time of the recording, unless a longer period is necessary in a particular case, taking into account the purpose of the register. Out-of-date and redundant data will be destroyed in an appropriate manner.

Rights of the data subject

You have various rights under the EU General Data Protection Regulation. Depending on the situation, you may have the right to:

- obtain confirmation of whether or not personal data concerning you is being processed and if it is, you have the right to access it
- have inaccurate personal data about you corrected or, in some cases, have incomplete data completed
- have your personal data erased
- restrict processing under certain conditions
- receive the personal data you have provided to us about yourself in a structured, commonly used, and machine-readable format and you also have the right to have this data transferred to another controller
- object to the processing of your personal data in situations where the processing is based on a legitimate interest
- withdraw your consent at any time, if the processing of your personal data is based on consent.
